

Wedding Contract

It is mutually agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of this contract shall be effective unless accepted by Prestige Photo in writing.

A non-refundable booking fee will be payable at the time of booking.

The client(s) agrees to pay the balance due at least one calendar month prior to the event day. No work shall be carried out by Prestige Photo until full payment has been received and cheques have cleared. Any bank charges that are incurred due to returned cheques will be charged to the client(s). Failure to comply with our terms of payment gives Prestige Photo the right to refuse to carry out the requested photographic services without refund or any other compensation.

Additional photographs will be charged at the cost in force at time of ordering.

Prestige Photo reserve the right to cancel this agreement at any time for whatever reason with a refund limited to monies paid without extra penalty on our part. If the client(s) cancels this contract 4 weeks or less prior to the wedding the client(s) will be liable to pay Prestige Photo the sum of £450. If the client(s) cancels this contract 5-15 weeks prior to the wedding the client(s) will be liable to pay Prestige Photo the sum of £400. If the client(s) cancels this contract 16-36 weeks prior to the wedding the client(s) will be liable to pay Prestige Photo the sum of £350.

The client(s) agrees to advise Prestige Photo immediately, in writing, of any alterations including postponement or cancellation of the event.

Preview photographs are supplied as low resolution digital files on CD/DVD.

Although Prestige Photo will do their best to produce more photographs than specified with the client(s), there is no guarantee that any particular number of photographs will be produced.

Prestige Photo cannot be held responsible for the lack of coverage caused by the bride, bridegroom or other members of the wedding party not being ready on time, nor by restrictions placed on the photographer by officials of the church, register office or licensed marriage venues. Prestige Photo will not be responsible for lack of coverage due to members of the wedding party not being available when called for a shot or if the wedding is running late. Prestige Photo does not guarantee any specific picture nor to include any specific background, location, props or arrangement, although every effort will be made to interpret the client(s)'s wishes.

Prestige Photo shall be the sole professional photographer at the wedding and will be granted artistic licence in relation to the photographs taken. The decisions taken by Prestige Photo regarding location, poses, etc shall be deemed correct.

It is sometimes impossible to record on camera the exact colour of materials as seen by the human eye. The photographs will provide a pleasing colour balance based on flesh tones. Exact colour matching from the original photographs, negatives or digital files cannot be guaranteed on any reprints. Colours will try to match the original photographs but may vary.

All negatives, transparencies, digital files or any other media of the original images taken in respect of this agreement shall remain the sole property and copyright of Prestige Photo. It is a criminal offence to copy or reproduce any of the photographs by any means, including video, under the terms of the Copyright, Designs and Patents Act 1988, failure to correspond may result in legal action.

Prestige Photo reserves the right to use any media of the original images taken in respect of this agreement for promotional or commercial purposes without any compensation to the subjects in the images. These promotional or commercial uses may include, but are not exclusive, or limited to, use on Prestige Photo's website, advertising material, sale of the image(s) or any other use.

All work undertaken by Prestige Photo is subject to our standard terms and conditions, without exception.

Whilst every care is taken this contract is subject to alteration or cancellation by Prestige Photo owing to any cause(s) beyond our control, i.e. act of god, war, fire, road closure.

In the unlikely event that all of the photographs fail to materialise or if there is a total photographic failure due to reasons beyond their control the liability of Prestige Photo will be limited to the refund of all monies paid. Neither party shall be responsible for indirect or consequential loss.

This should not be considered an exhaustive list of terms and conditions. If you have any specific legal questions please check with Prestige Photo.

I have read and fully understand the terms of this contract and accept that upon payment of the booking fee this contract becomes legally binding immediately. I agree that the cancellation fee will apply in the case of any cancellation by us in writing.
